




Figure 1-1 Bullet Camera Overview

Note:

- Microphone interface varies according to different device models. Please refer to the actual device.
- Press and hold the reset button about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC or PoE, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection. Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

2.1 Memory Card Installation

Follow the steps to mount and unmount the memory card.

Steps:

1. Loosen the screws to remove the memory card slot cover.




Figure 2-1 Unscrew the Cover and Insert Memory Card

- 2. Insert the memory card into the memory card slot.
- 3. (Optional)To unmount the memory card, push to get it ejected.
- 4. Screw the cover back to the camera.

2.2 Ceiling Mounting

Before you start:

Both wall mounting and ceiling mounting are suitable for the bullet camera. Ceiling mounting will be taken as an example in this section. And you can take steps of ceiling mounting as a reference for wall mounting.

Steps:

- 1. Paste the drill template (supplied) to the desired mounting position on the ceiling.
- Drill the screw holes in the ceiling according to the supplied drill template.

Note:

Drill the cable hole, if adopting ceiling outlet to route the cable.



Figure 2-2 Drill Template

- Route the cables through the cable hole (optional), or the side opening.
- 4. Fix the camera on the ceiling with supplied screws.




Figure 2-3 Fix the Camera on the Ceiling

Note:

- In the supplied screw package, both self-tapping screws, and expansion bolts are contained.
- If the ceiling is cement, expansion bolts are required to fix the camera. If the ceiling is wooden, self-tapping screws are required.
- Connect the cables and power on the camera to view live view image.
- 6. Adjust the surveillance angle.
 - Loosen the No.1 adjusting screw to adjust the rotation position [0° to 360°].
 - 2) Tighten the No.1 adjusting screw.
 - Loosen the No.2 adjusting screw to adjust the tilting position [0° to 90°].
 - 4) Tighten the No. 2 adjusting screw.
 - Loosen the No.3 adjusting screw to adjust the pan position [0° to 360°].

6) Tighten the No.3 adjusting screw.




Figure 2-4 3-aix Adjustment

 (Optional) Install the waterproof jacket. Refer to 2.4 Waterproof Measures for details.

2.3 Wall Mounting with Junction Box

Before you start:

- Both wall mounting and ceiling mounting are suitable for the bullet camera. Wall mounting will be taken as an example in this section. And you can take steps of wall mounting as a reference for ceiling mounting.
- The junction box is not included in the package. You need to prepare one for this mounting type

Steps:

- 1. Paste the drill template (supplied) to the desired mounting position on the wall.
- Drill the screw holes and the cable hole (optional) in the wall according to the drill template.

Note:

Drill the cable hole, if adopting ceiling outlet to route the cable.




Figure 2-5 Drill Template

- Take apart the junction box, and align the screw holes of the bullet camera with those on the junction box's cover.
- Fix the camera on the junction box's cover with three PM4 × 10 screws.




Figure 2-6 Fix the Camera on Junction Box's Cover

Secure the junction box's body with three supplied screws on the wall.




Figure 2-7 Fix the Junction Box on the Wall

- 6. Route the cables through the cable hole. Here we take bottom cable hole as the example to describe the installation.
 - 1). Separate the waterproof cover and the cable gland from the junction box.
 - 2). Route the cable through the bottom cable hole and the cable gland.
 - 3). Screw the cable gland back on the bottom cable hole.
 - 4). Screw the waterproof cover back on the side cable hole.
- Combine the junction box cover with its body with three screws on the junction box's cover.




Figure 2-8 Combine Junction Box's Cover with its Body

8. Repeat steps 5 to 7 of 2.2 Ceiling Mounting to complete the installation.

2.4 Waterproof Measures

If the camera is installed outdoor, you should use the waterproof accessory or tapes to waterproof the cables. Otherwise the cables might get wet or a short circuit occurs.

2.4.1 Install Network Cable Waterproof Jacket




Figure 2-9 Install Waterproof Jacket

Steps:

- 1. Feed the network cable through 1 and 3 in order.
- 2. Fix (2) on the network cable between (1) and (3).
- 3. Place (5) onto the end of (6), and plug the RJ45 male connector into RJ45 female connector.
- 4. Screw (3) to (6) clockwise
- 5. Push (2) into (3).
- 6. Secure (1) with the (3) in clockwise direction.

2.4.2 Waterproof Other Cables

After routing and connecting the cables, use the waterproof tapes to wrap up the cables. Connected cables and spare cables both should be wrapped up as the figures below.




Figure 2-10 Waterproof Cables

3 Setting the Network Camera over the LAN

Note:

3.1 Wiring

Connect the camera to network according to the following figures.




Figure 3-2 Connecting via a Switch or a Router

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for Activation via Client Software.

3.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- 2. Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

- 3. Create a password and input the password into the password field.
 - STRONG PASSWORD RECOMMENDED- We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.
- 4. Confirm the password.
- 5. Click OK to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera.

Steps:

- 1. Run the SADP software to search the online devices.
- 2. Check the device status from the device list, and select the inactive device.

Create and input the new password in the password field, and confirm the password.

And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

Note:

You can enable the Hik-Connect service for the device during activation. Refer to Chapter 5.1 for detailed information.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an active device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

 Input the admin password and click Modify to activate your IP address modification.

The batch IP address modification is supported by the SADP. Refer to the user manual of SADP for details.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

You may have to close the web browser to finish the installation of the plug-in.

5 Operating via Hik-Connect App

Purpose:

Hik-Connect is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Hik-Connect service is not supported by certain camera models.

5.1 Enable Hik-Connect Service on Camera

Purpose:

Hik-Connect service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Hik-Connect Service via SADP Software

Steps:

- 1. Check the checkbox of Enable Hik-Connect on:
 - 1). "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
- 2. Create a verification code or change the verification code.

- 3. Select Platform Access Mode as Hik-Connect.
- 4. Check the checkbox of Enable.
- Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
- 6. Create a verification code or change the verification code for the camera.

Note:

The verification code is required when you add the camera to Hik-Connect app.

7. Save the settings.

5.2 Hik-Connect Setup

Steps:

- Download and install the Hik-Connect app by searching "Hik-Connect" in App Store or Google Play[™].
- 2. Launch the app and register for a Hik-Connect user account.
- 3. Log in Hik-Connect app after registration.

5.3 Adding Camera to Hik-Connect

Before you start:

You need to enable the Hik-Connect service on camera before adding it to your Hik-Connect account. Refer to Chapter 5.1.

Steps:

 Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

Note:

After the camera connects to the network, please wait one minute before any operation on the camera using Hik-Connect app.

 In the Hik-Connect app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera. You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.




Figure 5-4 Scan QR Code

Note:

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the discontant inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Hik-Connect service on camera.
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser.
- Follow the prompts to set the network connection and add the camera to your Hik-Connect account.

Note:

For detailed information, refer to the user manual of the Hik-Connect app.

5.4 Initializing the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
