





This camera is waterproof and in compliance with the IP66 spec, but the jack connected to the external cable is not. You are recommended to install this product below the edge of eaves to prevent the cable from being externally exposed.


Precautions before installation

Ensure you read out the following instructions before installing the camera:


- Select an installation site that can hold at least 5 times the camera's weight.
- Stuck-in or peeled-off cables can cause damage to the product or a fire.
- For safety purposes, keep anyone else away from the installation site. And put aside personal belongings from the site, just in case.
- If the product is installed with excessive force, it may cause damage to the camera due to malfunction. Forcing assembly using non-compliant tools may damage the product.
- Do not remove the lens module while the power is on.

Disassembling


1. Remove the dome cover by loosening the fastening bolt of the dome cover. This can be done by turning it counterclockwise using the Allen key or drill bit provided.



2. Loosen the fastening screw on the camera body.




3. Remove the camera body and mounting plate by pulling the plate spring, as shown in the figure.



Inserting a Micro SD Memory Card

- 1. Remove the dome cover of the camera.
- 2. Insert a Micro SD card in the arrow direction shown in the figure.






- Disconnect the power cable from the camera before inserting the Micro SD memory card.
- Do not forcefully insert it in the reverse direction. It might damage your Micro SD memory card and your product.
- When it rains or the humidity is high, insertion or ejection of a Micro SD card is not recommended.
- Disassembly of the product cover should be finished within 5 minutes, or there will be the risk of internal dew condensation.

Removing a Micro SD Memory Card


Gently press down on the exposed end of the memory card as shown in the diagram to eject the memory card from the slot.



- You should save an SD card for each channel.
 - Please note that if you firmly push and release the Micro SD memory card when it is ejected, it may pop out.
 - Before removing the Micro SD memory card, in <Storage>, set the device to <Off> and press the [Apply] button and turn
 the camera off
 - If you turn off the camera or remove the Micro SD memory card that contains data from the product, the data may be lost or damaged.

Mounting lens module

- 1. Align and fasten the connector of the lens module with the connector of the camera body.
- Install the lens module while power is not connected (PoE+).
 - Check if the power switch is "OFF" before installing the lens module.
 - You are recommended to avoid touching the lens separately, as it is shipped from the factory with the focus adjusted during the manufacturing inspection.




- 2. Complete the lens mounting process.
- 3. Connect power to the product (PoE+).
- If you want to replace the lens module while connecting power to the product (PoE+), turn the power switch "OFF", replace the lens module, and then turn the power switch "ON".
 - Be careful not to use any tool with a sharp point when handling the switch since it might be damaged.
 - Be careful not to forcefully handle the switch since it might be damaged.




How to install using the perpendicular falling method

You can move the lens for only one channel to see the video after installing it in the direct-lit manner. In this case, the lens direction of the moved channel can be tilted up to 90 degrees.


1. Tilt the lens module part forward-facing and then pull it.



2. Align the groove with the center of the rotating part.



- 3. Lift the part with diagonal lines to release the frame
- 4. Move the three channel lenses along the bottom rail.




How to install using the tilting method

You can move the lenses of CH1 - CH4 along the bottom rail to view videos by installing them using the tilting method.


In this case, the orientation of the lens cannot be tilted by 90 degrees.

- 1. Mount the frame pan.
- 2. Remove the direct-lit lens from the rotation center.
- 3. Move the four channel lenses along the bottom rail.



Installation on a ceiling or wall

 Use the provided template to drill holes for installation (diameter 6 mm and minimum depth 45mm) and insert the supplied plastic anchors to the end.




2. Align the holes of the mount plate for installation with the holes inserted with plastic anchors, and fasten the tapping screws.



3. Connect the safety cable.



- 4. Mount the camera body to the mount plate.
 - Mount it to fit the hinges as shown in the image.
- Connect the terminal inside camera with the required cable.
 - If the lens module is not attached correctly, the lens module status light will illuminate red, as shown in the figure. If this occurs, turn off the power switch and reattach the lens module. If attached normally, it will illuminate green and then turn off after approximately 40 seconds.
- 6. Push in the pin spring.
- Adjust the lens to the desired direction by referring to "Adjusting the monitoring direction for the camera". (Page 17)
 - If you tilt the lens, you may need to adjust the lens as this may block the screen.



- 8. Assemble the dome cover.
 - Align the arrows when assembling the dome cover.
 - To ensure there are no issues with waterproofing, tighten the fastening bolts tightly using the Allen key or drill bit.



Attaching to the unbundled adapter

Choose and purchase a necessary one of the following options (unbundled) that is suitable to the installation site or for your convenience.

- 1. Install the hanging mount to the wall mount adapter.
 - Wall mount adapters and hanging mounts are sold separately.




2. Connect the mounting plate and the hanging mount.



3. Connect the safety cable.



- 4. Mount the camera body to the mount plate.
 - Mount it to fit the hinges as shown in the image.
- Connect the terminal inside camera with the required cable.
- 6. Push in the pin spring.
- Adjust the lens to the desired direction by referring to "Adjusting the monitoring direction for the camera". (Page 17)
 - If you tilt the lens, you may need to adjust the lens as this may block the screen.




- 8. Assemble the dome cover.
 - Align the arrows when assembling the dome cover.
 - To ensure there are no issues with waterproofing, tighten the fastening bolts tightly using the Allen key or drill bit.




Method 1. Connecting the LAN cable

- 1. Remove the dome cover and the case.
- 2. Pull out the long projected part of the rubber plug on the bottom and remove it as shown in the figure.
- Use an appropriate cable bush for the LAN cable to be connected.
 - Basic camera : Use the cable with a diameter of \emptyset 5~6.5.
 - Components provided : Use the cable with a diameter of $\emptyset7{\sim}8.5$.




- 3. Insert the LAN cable through the hole appeared after removing the projected part in step 2 above.
- 4. Remove the sheath with a cable cutter, and align the cables.
- 5. Connect the LAN cable with a LAN connector, and insert it into the LAN tool.
- 6. Connect the finished cable to the Ethernet port.




Method 2. Connecting the LAN cable


- 1. Remove the dome cover and the case.
- 2. Pull out the long projected part of the rubber plug on the bottom and remove it as shown in the figure.
- 3. Pull the rubber cover over the hole to remove it.




4. Use the Cap Installer to allow the RJ45 cable to pass through.







Insert the rubber stopper again and connect the LAN cable to the Ethernet terminal.



How to set up channels to monitor for installation


The camera body has a channel DIP switch, as shown in the figure.

You can change the channel of the camera using the channel DIP switches.

- If a DIP switch is not fully On/Off, the product may malfunction. After installation, check the DIP switches at the back.
- Be careful, as you will risk damaging a DIP switch if you manipulate it using a sharp tool.
- Be careful, as a DIP switch may be damaged if you operate it with excessive force.



Outdoor installation

When you install it outside of the building, please waterproof it with waterproof butyl rubber tape (can be purchased in stores) so that water does not leak from the gap of the cable connected to the outside.

- 1. Connect the PoE cable.
- 2. Wrap the black cable jacket (Area A) and the cable connection area with waterproof (butyl rubber) tape so that more than half of the butyl rubber tape is overlapped.






- If the cable jacket is not waterproofed properly, then it can directly cause leakage. Make sure to protect the cable with a dense layer of taping.
- Waterproof butyl tape is made of butyl rubber that can be stretched to twice its normal length.

4. CORNER MOUNT ADAPTOR (SBP-300KM) This is an adaptor for WALL MOUNT ADAPTOR (SBP-300WM or SBP-300WM1) installation on the corner of wall joint.



Adjusting the monitoring direction for the camera





Adjusting the monitoring direction


You can adjust the camera direction only when the camera is fixed on the ceiling. The act of moving the camera module is called "Pan"; adjusting its angle "Tilt"; rotating the lens along the axis "Rotate".

- The rotation angle of Pan is -90° to +90° for each module.
- The rotation angle of Rotation is -180° to +180°.
- The rotation angle of Tilt varies for each lens. See the detailed specs. (Page 27)
- 1
- The image can be covered up by the camera case depending on the angle.
- Do not pan over the specified rotation angle. It might damage the cable leading to a product malfunction.

Methods of adjustment

- After installing the camera in consideration of the direction to monitor, adjust the Pan angle along the bottom rail.
- 2. Adjust the horizontal angle so that the image does not appear to be reversed during rotation.
- 3. Adjust the tilt angle so that it points in the direction to be monitored.

CONNECTING WITH OTHER DEVICE



The CVBS out terminal of the product is provided for easier installation, and is not recommended for monitoring purposes.

Powering and networking

Connect the PoE+ device with the PoE terminal of the camera.



Use a PoE+ device that complies with the IEEE802.3at standard.



Connecting to the camera from a local PC in the LAN

- 1. Launch an Internet browser on the local PC.
- 2. Enter the IP address of the camera in the address bar of the browser.



- A remote PC in an external Internet out of the LAN network may not be able to connect to the camera installed in the intranet if the port-forwarding is not properly set or a firewall is set.
- In this case, to resolve the problem, contact your network administrator.
- In the IP installer, you can use the initial password, "4321" to set IP Address, Subnet Mask, Gateway, HTTP Port, VNP Port, IP type. After changing the network interface, for better security, access the web viewer and change the password.
- By factory default, the IP address will be assigned from the DHCP server automatically. If there is no DHCP server available, the IP address will be set to 192,168,1,100, To change the IP address, use the IP Installer. For further details on IP Installer use, refer to "Static IP Setup". (Page 19)
